

TERMS OF USE

1. GENERAL CONDITIONS

This User Agreement (hereinafter referred to as the Agreement) refers to the site "Konstantin Chaykin" located at <http://www.chaykin.ru>.

The information provided on the pages of this site is purely advertising and informational in nature and under no circumstances is a public offer determined by the provisions of Article 437 (2) of the Civil Code of the Russian Federation. 1.3. The website "Konstantin Chaikin" (hereinafter referred to as the Site) is the property of a legal entity Limited Liability Company "Konstantin Chaikin".

1.4. This Agreement governs the relationship between the Administration of the site "Konstantin Chaikin" (hereinafter referred to as the Administration of the site) and the User of this Site.

1.5. The site administration reserves the right to change, add or delete clauses of this Agreement at any time without notifying the User.

1.6. Use of the Site by the User means acceptance of the Agreement and changes, included in this Agreement.

1.7. The user is personally responsible for checking this Agreement for changes in it.

2. APPLIED TERMS

2.1. In these General Conditions and the Contract the following terms will be applied:

2.1.1 "Konstantin Chaikin" - an Internet resource located on a domain name <http://www.chaykin.ru>, operating through the Internet resource and related services (hereinafter referred to as the Site).

2.1.2. "Konstantin Chaikin" is a site containing information about the Goods and / or Services and / or Other values for the user, the Seller and / or the Service Provider, allowing to make a choice, order and (or) purchase the Goods, and / or receive the service.

2.1.3. Site administration - authorized employees to manage the Site, acting on behalf of a legal entity Limited Liability Company "Konstantin Chaikin".

2.1.4. Site user (hereinafter referred to as the User) is a person who has access to the Site, via the Internet and using the Site.

2.1.5. The content of the site (hereinafter referred to as the Content) is the protected results of the intellectual activities, including the texts of literary works, their titles, prefaces, annotations, articles, illustrations, covers, musical works with or without text, graphic, textual, photographic, derivatives, composite and other works, user interfaces, visual interfaces, product names signs, logos, computer programs, databases, as well as design, structure, selection, coordination, appearance, general style and arrangement of this Content included in the Site and other objects of intellectual property all together and / or separately contained on the site <http://www.chaykin.ru>.

3. SUBJECT OF THE AGREEMENT

3.1. The subject of this Agreement is to provide the User with access to the Products and / or services provided on the Site.

3.1.1. The site provides the User with the following types of services (services):

- access to search tools and site navigation;
- access to information about the Product and / or service to information about the purchase of the Product on paid / free basis;

3.1.2. All existing (actually functioning) at the moment the services (services) of the Site, as well as any of their subsequent modifications and additional services appearing in the future (Services).

3.2. Access to the site is provided free of charge.

3.3. This Agreement is a public offer. Accessing the Site

The user is considered to have acceded to this Agreement.

3.4. The use of materials and services of the Site is governed by the rules of the current legislation of the Russian Federation.

4. LIABILITIES OF THE PARTIES

4.1. The site administration has the right to:

4.1.1. Change the rules for using the Site, as well as change the content of this Site. Changes come into force from the moment the new version of the Agreement is published on the Site.

4.2. The user has the right to:

4.2.1. Use all the services available on the Site, as well as purchase any Products and / or Services offered on the Site.

4.2.3. Use the Site solely for the purposes and in the manner provided Agreement and not prohibited by the legislation of the Russian Federation.

4.2.4. Copying information from the Site is allowed.

4.2.5. Require the administration to hide any information about the user.

4.2.6. Use site information for commercial purposes without special permission.

4.3. The Site User undertakes:

4.3.1. Provide, at the request of the Site Administration, additional information that is directly related to the services provided by this Site.

4.3.2. Observe the property and non-property rights of authors and other copyright holders when using the Site.

4.3.3. Take no action that could be considered in violation normal operation of the Site.

4.3.4. Not to distribute using the Site any confidential and protected by the legislation of the Russian Federation information about individuals or legal entities.

4.3.5. Avoid any actions that may result in disruption confidentiality of information protected by the legislation of the Russian Federation.

4.3.6. Do not use the Site to disseminate advertising information, except with the consent of the Site Administration.

4.3.7. Do not use the services for the purpose of:

4.3.7.1. violation of the rights of minors and (or) causing harm to them in any form.

4.3.7.2. infringement of the rights of minorities.

4.3.7.3. posing as another person or representative of the organization and (or) communities without sufficient rights, including for the employees of this site.

4.3.7.4. misleading about the properties and characteristics of any Goods and / or services posted on the Site.

4.3.7.5. incorrect comparison of the Goods and / or Services, as well as the formation of a negative attitude towards persons (not) using certain Goods and / or services, or condemnation of such persons.

4.3.8. Ensure the accuracy of the information provided

4.3.9. Ensure the safety of personal data from access by third parties.

4.4. The user is prohibited from:

4.4.1. Use any devices, programs, procedures, algorithms and methods, automated devices or equivalent manual processes for accessing, acquiring, copying or tracking the content of the Site.

4.4.2. Disrupt the proper functioning of the Site.

4.4.3. In any way bypass the navigation structure of the Site to obtain or attempt obtaining any information, documents or materials by any means that are not specifically represented by the services of this Site.

4.4.4. Unauthorized access to the functions of the Site, any other systems or networks related to this Site, as well as to any services offered on the Site.

4.4.5. Violate the security or authentication system on the Site or on any network, related to the Site.

4.4.6. Perform a reverse search, track or attempt to track any information about any other User of the Site.

4.4.7. Use the Site and its Content for any purpose prohibited by the legislation of the Russian Federation, as well as incite any illegal activity or other activities that violate the rights of the Site or others.

5. PERSONAL DATA TREATMENT AND CONFIDENTIALITY

5.1. The Site and the Content that is part of the Site is owned and operated by Site administration.

5.2. The content of the Site is protected by copyright, trademark law, and other rights related to intellectual property, and legislation on unfair competition.

5.3. This Agreement applies to all additional terms and conditions for the purchase of Goods and / or the provision of services provided on the Site.

5.4. The information posted on the Site should not be construed as a change present agreement.

5.5. The site administration has the right at any time without notifying the User to make changes to the list of Products and services offered on the Site, and (or) their prices.

5.6. The document specified in clause 5.7.1 of this Agreement regulates in the relevant part and extends its effect to the use of the Site by the User:

5.8. Any of the documents listed in clause 5.7.1. of this Agreement may subject to renewal. Changes come into force from the moment they are published on the Site.

6. RESPONSIBILITIES

6.1. Any losses that the User may incur in the case of intentional or careless violation of any provision of this Agreement, as well as due to unauthorized access to the communications of another User, are not reimbursed by the Site Administration.

6.2. The site administration is not responsible for:

6.2.1. Delays or disruptions in the process of completing the transaction arising from force majeure, as well as any case of malfunctions in telecommunications, computer, electrical and other related systems.

6.2.2. Actions of transfer systems, banks, payment systems and for delays associated with their work.

6.2.3. The proper functioning of the Site, if the User does not have the necessary technical means for its use, and also does not bear any obligations to provide users with such means.

7. VIOLATION OF CONDITIONS

7.1. The site administration has the right to disclose information about the User if the current legislation of the Russian Federation requires or permits such disclosure.

7.2. The site administration has the right without prior notice to the User terminate and (or) block access to the Site if the User has violated this Agreement or the terms of use of the Site contained in other documents, as well as in the event of termination of the Site or due to a technical problem or problem.

7.3. The site administration is not responsible to the User or third parties persons for termination of access to the Site in case of violation by the User of any the provisions of this Agreement or other document containing the terms of use of the Site.

8. APPLICABLE LAW. JURISDICTION. EXPIRY

8.1. In the event of any disagreement or dispute between the Parties to this Agreement, a prerequisite for filing a claim (a written proposal for a voluntary settlement of the dispute) is a prerequisite before going to court.

8.2. The recipient of the claim within 30 calendar days from the date of its receipt, in writing notifies the applicant of the claim about the results of the consideration of the claim.

8.3. If it is impossible to resolve the dispute on a voluntary basis, either of the Parties has the right apply to the court for the protection of their rights, which are granted to them by the current the legislation of the Russian Federation.

8.4. Any claim regarding the terms of use of the Site must be filed within 5 days after the grounds for the claim arise, with the exception of copyright protection for the materials of the Site protected in accordance with the law. In case of violation of the terms of this clause, any claim is left by the court without consideration.

9. ADDITIONAL TERMS

9.1. The site administration does not accept counter offers from the User regarding changes to this User Agreement.
